## AGENDA ITEMS

### **1. Motion**

Commissioner Tope made a motion to hold the election to fill the vacancy in SMD 3F02 and approve the election rules as circulated. The motion was approved with 5 voting in favor, 0 voting against, and 0 abstaining (5-0-0). Voting began at 7:05 pm.

### **2. Motion**

Commissioner Nugent made a motion to approve the 2015 third quarter (Q3) Financial Report. The motion was approved with 5 voting in favor, 0 voting against, and 0 abstaining (5-0-0).

### **3. Motion**

Commissioner Jakopchek made a motion to oppose the public space permit application for an over-height wall at 4209 Linnean Avenue NW pending a full 45-day review of the application.

Discussion: Commissioner Jakopchek noted that the application was received with only 15 days for response instead of the required 45 and that the applicant had not provided the details necessary for a full review.

The motion was approved with 5 voting in favor, 0 voting against, and 0 abstaining (5-0-0).

### **4. Resolution**

Voting in the election to fill the vacancy in SMD02 concluded at 8:30 PM. Two officials from the Office of Advisory Neighborhood Commissions counted the ballots and declared Shirley Adelstein the winner by a vote of 149-38.

Commissioner Tope offered a resolution to to ask the DC Board of Elections to declare the vacancy in Special Member District 3F02 filled by Shirley Adelstein. The resolution was approved with 5 voting in favor, 0 voting against, and 0 abstaining (5-0-0).
