Many thanks again to you and the Commissioners for providing a grant of \$325 to Iona to help create the Where to Find Food Map and Guide for Ward 3.

To create the Food Guide for our Ward 3 neighbors, Iona worked with the DC Greens design vendor and printer, using the detailed information on Ward 3 resources that was compiled by Iona's food access coordinator, Ashlea Steiner.

In addition to ANC 3-F's favorable decision on a grant, Iona was fortunate to receive the same grant amount from ANC 3-C, 3-B, and 3-E. We were also thankful to receive a matching gift from a Ward 3 resident who read about the grant application in the NW Current. Having secured the investment of some ANCs and the individual, we achieved sufficient funding to go into production of the Guide.

Today we took delivery on 1,000 copies of the Guide (enclosed), and will be immediately disseminating 250 of them to targeted 3F audiences in urgent need of this information, which includes Ward 3-specific locations and phone numbers for where to find emergency and low-cost groceries, free meals, food for seniors and the homebound, and how to apply for food benefits.

Iona is grateful to the Commissioners of ANC3-F for investing in a resource that will be very helpful to our Ward 3 neighbors of all ages who are quietly struggling at the edge of hunger and malnutrition.
