Dear Mr. Nugent:

Thank you for your guidance in applying for permission for a sidewalk café at the above premises. As you know, our neighbors at 5010 and 5018 Conn. Ave. already have sidewalk cafes, and we fit right in the middle of these two, and are similar in size and scope to the cafe at 5010.

Our minimalist design consists of an unenclosed seating area containing 5 tables and 10 chairs. Planters define the perimeter to the South and East. None of these elements are attached to the pavement. We do not have logos or advertising for other parties.
