**Resolution on the Extension of the Clean Team North of Van Ness St. to Extend Services to Chevy Chase Circle**

WHEREAS, the District Government operates the Clean Team, an element of the Department of Small and Local Business Development (DSLBD); and

WHEREAS, the Clean Team offers commercial areas that do not fall under a Business Investment District (BID) with such services as the removal of litter and graffiti, snow and ice clearance, recycling collection, tree maintenance, planters, and support with tracking public space defect requests via 311; and

WHEREAS, DSLBD extended Clean Team service in FY14 to parts of Connecticut Ave.; and

WHEREAS, DSLBD agreed in email correspondence to an informal request from Commissioner Priniotakis to extend service on Connecticut Ave. to cover the 5000 block of Connecticut Ave. all the way to the DC-Maryland border at Chevy Chase Circle in FY15; and

WHEREAS, DSLBD reversed that decision, also via email, citing unclear budget concerns; and

WHEREAS, Clean Teams provide much-needed services to business districts that fall outside of concentrated business zones covered by BIDs and support the District's sustainability goals; and

WHEREAS, the businesses and residents of ANC 3F along and near Connecticut Ave. from Van Ness St. to Nebraska Ave. would benefit from Clean Team coverage, with similar benefits going to residents of ANC 3/4G if the extension reaches Chevy Chase Circle, as was suggested by DSLBD staff via email.

THEREFORE, BE IT RESOLVED, for the reasons stated above, ANC 3F supports the extension of Clean Team services on Connecticut Ave. to cover business districts between Van Ness St. and Nebraska Ave. in FY15, with consideration of extension of services as far north as Chevy Chase Circle; and


BE IT FURTHER RESOLVED that ANC 3F calls on DSLBD to request funding for this coverage for FY16 to ensure extension of Clean Team activities.

BE IT FURTHER RESOLVED that Commissioner Manolis Priniotakis is authorized to speak on behalf of ANC 3F regarding this issue.
